Duplication Policy and Procedures

General

Researchers may request duplication or take photographs of archival materials for study purposes only, and as allowed by the Menil Archives, based on the physical condition of materials, copyright law, donor restrictions, and Archives policy.

Please allow two to three weeks to process all digital duplication and image requests. Audiovisual duplication may take six to eight weeks.

The Menil Archives does not charge a fee for routine duplication. Archives reserves the right to assess a fee, based on time and quantity, for staff fulfilled large volume duplication orders.

Self-taken photographs are limited to 20% of a collection.

Rights and Permissions

Archival materials may be protected by copyright, trademark, privacy and publicity rights, or other intellectual property rights (collectively “IP rights”) not owned by the Menil. The Menil Archives is not responsible for determining the IP rights of archival materials or for securing permissions.

Possession of a reproduction does not constitute permission to use, reproduce, or distribute it. Duplicated materials may not be transferred to any other institution or individual without written permission.

Permission to use duplicated materials other than for private study, scholarship, or research requires the permission of the Menil Archives. Requests to reproduce or publish archival materials should be submitted in writing to the Archives and are coordinated with the Menil’s Rights and Reproductions department.

Citations

It is the researcher's responsibility to keep accurate citations for all items duplicated or photographed, which are required when requesting permission to publish or quote.
